I. Welcome and Introductions

The monthly meeting of the Middle Peninsula Planning District Commission was held in the Regional Board Room at the Middle Peninsula Planning District Commission office in Saluda, Virginia on Wednesday, April 24, 2019, at 7:00 p.m. In the absence of the Chairman, MPPDC Vice-Chairman, Ashley Chriscoe welcomed everyone in attendance.

II. Approval of March Minutes

Vice-Chairman Chriscoe asked whether there were any corrections or changes to the March Minutes. There being no corrections to the Minutes, Vice-Chairman Chriscoe requested a motion to approve the March Minutes. Mr. Moskalski moved that the March Minutes be approved. Mr. Smith seconded the motion; motion carried.

III. Approval of March Financial Report

Vice-Chairman Chriscoe asked whether there were any questions regarding the March financial report before being approved subject to audit. There being no questions, Vice-Chairman Chriscoe requested a motion to approve the March financial report subject to audit. Mr. Rivara moved to approve the March financial report subject to audit. Mr. Hill seconded the motion; motion carried.

IV. Executive Director's Report on Staff Activities for the Month of April

Vice-Chairman Chriscoe requested MPPDC Executive Director, Lewie Lawrence review the Executive Director's Report on Staff Activities for the month of April. The Executive Director's Report on staff activities is developed at a monthly staff meeting, organized by PDC Service Centers, and the activities are used to report grant funding activities.

Mr. Lawrence directed the Commissioners' attention to several items:

- Consulted with Scott Hardaway, Director for Shoreline Studies Program at VIMS regarding FEMA standards for 15 and 25 year storm event calculations. Provided contact information for Russ Burk, Professor at Christopher Newport University to coordinate with Scott Hardaway on calculations.
- Consulted with staff from Virginia Geographic Information Network and the Virginia Department of Environmental Quality regarding the methodology used to calculate impervious cover and the relationship to solar. For the purposes of impervious cover and the tiered approach for stormwater regulations, determining how solar panels are classified for land-use classification is of critical importance to the Middle Peninsula. Mr. Lawrence drew the Commission's attention to a handout of a draft map of every HUC unit in the Middle Peninsula.
- Consulted with Melissa Fullorn, Virginia Port Authority regarding proposed budget for the four applications submitted to VPA requesting dredging funding. Ms. Fullorn requested amendments to the budget to phase planning and permitting separate from construction due to insufficient funds to finance even one of the proposed dredging projects.
- Consulted with a Northern Neck waterfront property owner interested in a loan for a living shoreline. Explained that the Middle Peninsula Planning District Commission Living Shoreline Revolving Loan Program is not open to citizens on the Northern Neck and that citizens should contact the Northern Neck Planning District Commission for information on what programs may be available to them.
- Provided a graph of localities from whom MPPDC staff requested tax-exempt parcel data. The checked localities have sent in the requested data and the unchecked localities have not provided a response. Mr. Lawrence stated Essex, King & Queen, King William, Accomack, Northampton and Richmond Counties have provided the requested data. Lancaster, Northumberland, Westmoreland, Gloucester, Mathews and Middlesex have not provided a response to date. This data will be used to locate publicly owned land to be used as possible dredge spoil sites.
- Conducted research on Uber/Lyft regarding a demand-responsive service to help alleviate the pressure on Bay Transit. Mr. Lawrence stated research is currently being done to determine how to modify how Uber or Lyft operate in

> rural communities; the possible creation of a hybrid urban Uber system for rural communities; and determine if there is enough demand for a consumer driven Uber alternative to Bay Transit in the Middle Peninsula.

Commissioners were encouraged to contact Mr. Lawrence with any questions regarding the staff activities reported for the month of April.

V. MPCBPAA Update

Mindy Conner, MPCBPAA Chairman reported the Virginia Outdoors Foundation (VOF) easement is almost finalized. The Middle Peninsula Chesapeake Bay Public Access Authority has received funds from the VOF to put a public access easement on Captain Sinclairs Landing Recreational Area. The PAA wants to use the funding to encourage recreation and business use and bring revenue back to the county. The Middle Peninsula Alliance is continuing to look to the Public Access Authority for a site for a Nutrient Credit Bank. The donation of a Marina is still active and the next scheduled meeting will take place at the Marina on June 14th.

VI. MPA Update

Travis Moskalski, MPA Chairman provided the Commission with an update on the recent activities of the MPA. Billy Beale, Chairman of GO Virginia Region 6 gave a PowerPoint presentation and discussed how the MPA can bring projects to GO Virginia to further their mission. Two GO Virginia Region 6 members were present. The MPA received a VA Tourism grant which will be used for tourism marketing on the MPA website and collateral material for handout. The MPA will host a site selector visit to the Middle Peninsula on May 2. The next scheduled meeting will take place on May 8th and Jenny Crittenden, Director of the Gloucester Main Street Preservation Trust will be the guest speaker. Mr. Moskalski thanked the Commission for their support.

VII. MPPDC Public Relations/Communications Update

Stephanie Heinatz, Consociate Media included this update in her presentation on WIP III, Resiliency and Flood Prevention.

VIII. Public Comment

None.

IX. Stephanie Heinatz, Consociate Media Presentation on WIP III, Resiliency and Flood Prevention

Stephanie Heinatz, Consociate Media gave a PowerPoint presentation illustrating the challenges and strategies to effectively relay to Middle Peninsula elected officials, and the community as a whole, the incredibly complex work of the Commission and to provide a better understanding of the work it does. Ms. Heinatz stated the WIP III talking points answered who we are, where we want to go and why the work of the Commission is so important. Ms. Heinatz was engaged to provide PR services for the Middle Peninsula Planning District Commission

through limited funding from the Coastal Zone Management Program and Department of Environmental Quality WIP III funds.

X. Adoption of Resolution in Support of Flood Resiliency Proposal to Department of Conservation and Recreation

MPPDC Executive Director, Lewie Lawrence provided the Commission with a draft Resolution in Support of a Flood Resiliency Proposal to Department of Conservation and Recreation required to request assistance from the 2019 Virginia Dam Safety, Flood Prevention and Protection Assistance Fund developed by the Department of Conservation and Recreation (DCR) in cooperation with the Virginia Resource Authority. Mr. Moskalski made a motion to accept the Resolution as presented. Mr. Rivara seconded the motion; motion carried.

XI. FEMA Update for the Middle Peninsula All Hazard Mitigation Plan

MPPDC Executive Director, Lewie Lawrence reminded the Commission that FEMA requires the Middle Peninsula All Hazard Mitigation Plan be updated every 5 years and it is time to begin to update this regional plan again. The MPPDC will apply the standard agreement with participating localities. Maximum local cost share is anticipated to be \$5000 per County and \$1500 for Town. There was discussion regarding inclusion of the federally recognized tribes. At the time of the last update, the tribes in the Middle Peninsula had not yet received federal recognition. Mr. Lawrence will keep localities updated.

XII. GO Virginia Presentation given to MPA Board by Billy Beale, GO Virginia Region 6 Chairman

Executive Director, Lewie Lawrence provided the Commission with a copy of the PowerPoint presentation Billy Beale, Chairman of GO Virginia Region 6 presented to the Middle Peninsula Alliance at their April meeting. Mr. Beale presented on the Virginia Initiative for Growth & Opportunity in each Region. Topics discussed were: The Growth and Opportunity Board; 9 Regional Councils; Annual Funding Allocation with Region 6 having \$1.2M on hand; Region 6 Growth and Diversification Plan; Top 6 Priority Growth Clusters; Funding Sources: Enhanced Capacity Building and Collaborative; Eligible and Ineligible GOVA Projects Defined: Application Process: Funded Projects: Engagement: and Region 6 Contact Information. Mr. Lawrence announced the MPA was recently awarded funding for Site Characterization, MPCBPAA Site Assessment and Nutrient Credit Bank on MPCBPAA property. The need for more awareness, projects and investment in Region 6 was also conveyed. GO Virginia is a business-led program with a goal to create more higher paying jobs through incentivized collaboration, primarily through out-of-state revenue, which diversifies and strengthens the economy of every region.

XIII. Other Business

Vice-Chairman, Ashley Chriscoe reported on the Region II VACo meeting he recently attended and directed the Commissioners on how to obtain a copy of the

Project 30502 Water Supply Planning

9 VAC 25-780 establishes a planning process and criteria that all local governments will use in the development of local or regional water plans. The plan will be reviewed by the Department of Environmental Quality and a determination will be made by the State Water Control Board on whether the plan complies with this regulation. Within five years of a compliance determination by the board, the plan will be reviewed to assess adequacy and any significant changes will require the submission of an amended plan and review by the board. All local programs will be reviewed, revised, and resubmitted to the Department of Environmental Quality every 10 years after the last approval. The jurisdictions of Essex, King and Queen, King William, Mathews, Middlesex, Tappahannock, Urbanna and West Point opted to prepare a regional plan with assistance from Middle Peninsula Planning District Commission staff and EEE Consulting, an environmental consulting firm. The Regional Plan was completed and submitted to the Virginia Department of Environmental Quality for compliance review by the November 2, 2011 deadline for Regional Plan submission.

Project 32017 – NAWCA PAA Acquisitions

The Wetlands Conservation on the Middle Peninsula of Virginia Phase I proposal is the first in a series of projects planned by the Middle Peninsula District Commission (MPPDC) in coordination with local, state and federal agencies, non-government organizations and landowners to protect key wetlands along the Chesapeake Bay. This project will employ a novel, creative and cost effective land conservation model in order to perpetually protect 77.05 acres of coastal habitat.

Funding Opportunity: National Fish and Wildlife Service - 2019 Chesapeake Bay Innovative Nutrient and Sediment Reduction and Small Watershed Grants Programs

Summary of Grant Opportunity: The National Fish and Wildlife Foundation (NFWF), in partnership with the U.S. Environmental Protection Agency (EPA) and the federal-state Chesapeake Bay Program partnership, is soliciting proposals to restore water quality and habitats of the Chesapeake Bay and its tributary rivers and streams. NFWF estimates awarding \$12-14 million in grants through the Chesapeake Bay Innovative Nutrient and Sediment Reduction (INSR) Grants and Small Watershed Grants (SWG) programs in 2019, contingent on the availability of funding. Major funding for the Stewardship Fund comes from the EPA. Other important contributions are provided by the U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) and U.S. Forest Service, the U.S. Fish and Wildlife Service, and Altria Group. Two separate Request for Proposals detailing NFWF's funding priorities and other key considerations are attached.

Project 32146 – ANPDC Ecotourism II

This project will build on efforts from the first year and extend Middle Peninsula Watertrails into the Mobjack Bay and the Severn River. The Rural coastal Virginia Ecotourism Steering Committee will refine the Virginia Watertrails website and will focus on marketing watertrails and eco-tourism in rural coastal Virginia.

- Reached out to Patty McGrath and Katey Legg of Gloucester County to inform them that MPPDC staff is available to help the Gloucester Blueway group expand watertrails and to share information, outreach material, etc. on the Virginia Watertrails website (VirginiaWatertrails.org). No response has been received to-date.
- Reached out to Emily Allen and Marcy Benouameur of Mathews County to inform them that MPPDC staff is available to help the Mathews Blueway group expand watertrails and to share information, outreach material, etc. on the Virginia Watertrails website (VirginiaWatertrails.org). Project 32147 – ANPDC Rural Enhancement Authority

ANPDC and MPPDC will host a Summit to engage interested localities towards their participation and membership in the Rural Coastal Virginia Community Enhancement Authority to further legislative advancements in Working Waterfront and other rural coastal Virginia policy.

 Consulted with Del. Keith Hodges concerning the Rural Coastal Enhancement Authority Summit to be held in late Spring or early Summer of 2019. Discussed agenda topics and speakers. Speaking topics will include Stormwater; Flooding; Economic Development; Collaborative Projects such as municipal dredging; VDOT Reform etc. Legislative items for the next General Assembly session will also be discussed.

Project 32148 - NNPDC WWF Video

This project proposes to expand available tools that help promote and ensure the sustainability of working waterfronts and related industries. Specifically, StoryMaps will be created for the Coastal Region that detail the locations and histories of selected working waterfronts and a video will be produced to capture the most important working waterfront stories of the coastal region of Virginia.

Project 32150 – CZM Extraction Fee Study

This project will explore the inequalities between different natural resource extr4avit industries in Coastal Virginia and beyond. MPPDC staff will review Virginia's current severance taxing framework and relation to existing natural resources extractive industries, and offer recommendations for next steps.

Project 32151 - NFWF Landowners Living Shorelines & Shoreline Management

This is a two-part project that focused on continuing coastal resiliency and mitigation efforts, while simultaneously improving water quality, managing shoreline erosion and mash loss. First, MPPDC staff will work directly with FEMA National Flood Insurance repetitive loss property owners to offer grant and loan funds through the MPPDC Living Shorelines Incentives Revolving loan to install living shorelines. Second, MPPDC will contract with VIMS to create a grant template to be used by localities to receive funding through the Virginia Waterway Maintenance Fund.

In addition, existing oyster bag sill installations at four private locations will be monitored to determine overall project effectiveness. This work will provide recommendations for installations along fetch-limited shorelines of Chesapeake Bay.

Project 30215 - Transportation Demand Management (TDM) Marketing Plan

Special emphasis will be placed on developing a social marketing plan to target regional out commuters and introduce the new Telework Center being constructed in King & Queen County. This is anticipated to be a 2-year project with the first year providing market research and design of the marketing plan and the second year, if funded, implementation of the plan.

ONSITE REPAIR & PUMPOUT

Funding -VRA Loan Funds, local match from MPPDC General Fund, cost sharing

Project 30420/30428 - On-Site Technical Guidance Assistance and Revolving Loan Program

The On-Site Technical Guidance Program aids the Middle Peninsula localities and residents in the technical understanding and implementation of approaches to address On-Site Disposal Systems and improve water quality by assisting local homeowners with repairing failing septic systems through low-interest loans and/or grants. In addition MPPDC received funding under the Water Quality Improvement Fund (WQIF) to provide grants to low to moderate income Middle Peninsula and New Kent County homeowners to repair failing septic systems impacting water quality and health in the region. Grants can be paired with loans from the MPPDC Onsite Wastewater Revolving Loan Fund to provide matching funds as required. It is anticipated this funding will be used to provide assistance to 20-27 homeowners.

- Continuing to receive phone calls from homeowners and contractors regarding assistance for septic repairs.
- Consulted with Boyd Wiley, DEQ Virginia Clean Water Revolving Loan Program regarding window to apply for new RLF capitalization.
- Convened Loan Committee to review application for Gloucester septic repair. Approved loan for \$21,009 for 107 months at 5.5% interest. Called homeowner and mailed approval letter. Homeowner has not responded.
- Since its inception, the MPPDC septic repair program has provided over \$1.3 million to 132 homeowners to repair failing septic systems \$612,000 in loans, \$571,000 in grants and \$41,000 in other funds. \$162,560 in loans receivable remain to be paid, \$420,200 has been repaid.
- Received notice of pumpout funding by DEQ. Approval of funds was less that in the proposal and included match that was also not in the proposal. Negotiated budget with Susan Hale, DEQ and was able to keep proposed scope (100 pumpouts) with minimal match commitment from MPPDC, majority of match to come from LMI homeowner cost-share. Contract forthcoming.

Project 301093 – PamunkeyNet

PamunkeyNet, a proposed wireless internet system which would harness the Middle Peninsula's existing emergency services radio infrastructure to create a regional internet service in Middle Peninsula localities. This project proposes to address the business structure necessary for the Pamunkey Nation to operate and become a wireless provider.

HOUSING

Funding -Housing Loan Program Income

Project 300132 - Energy Efficiency and Conservation Block Grant (EECBG) Revolving Loan Fund

The program emphasizes a community-based approach to help meet energy and climate protection goals. MPPDC was awarded a contract to provide weatherization renovations to 12 homeowners ineligible for LMI weatherization programs in each of the 6 counties. MPPDC subcontracted the promotion and construction portions of this project to Bay Aging but was tasked with administering the overall project. MPPDC is administering the revolving loan program per DMME.

- Executed ACH loan payments for MPBDP loans. All MPPDC loan funding programs require that loan recipients authorize loan payments to be made automatically from loan recipients' bank accounts. Loan clients authorize the payments at loan closing (ACH Authorizations). MPPDC staff process these payments on the 15th of each month. This places the onus to not make a payment on the loan client contacting MPPDC staff prior to the loan processing date of the 12th of the month to request a payment be held. This has significantly reduced defaults and delinquent repayments of MPPDC loans.
- *Funds available* = \$40,379

Project 30115 – VHDA Community Impact Grant

This project will consider new approaches to address vacant homes and clouds on deeds within the Middle Peninsula. Using recommendations derived from VCPC's extensive policy analysis, MPPDC will identify feasible strategies to address housing issues in the region. This work will also include a limited field inventory which will help MPPDC better evaluate how many vacant homes are in the Middle Peninsula. The short-term objective of Phase I is to identify tools available to address housing vacancies and determine how many vacant homes are in the Middle Peninsula. MPPDC will contract with VCPC and the Berkley Group to provide needed analysis and footwork.

Project 31207 - MP/NN Mass Casualty Exercise

The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs), identified the need of integrating as a region, including the need for a regional exercise that would require multiple jurisdictions to carry out a coordinated response to an incident. This functional exercise will include the Middle Peninsula, will invite the Northern Neck, and will provide jurisdictions that recently purchased regional support trailers, the opportunity to deploy and use that gear in a simulated real-world event.

Project 31208 – MP/NN Regional Debris Management Plan

The Middle Peninsula/Northern Neck Debris Management Plan improves and supports the jurisdictions within the Middle Peninsula/Northern Neck's Operational Coordination, Information Sharing and Recovery Planning. The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs) identified the need to develop a Regional Debris Removal Plan that would engage the 10 county area in a joint planning process.

- Consulted with Stephen Geissler, VPPSA regarding identifying gaps in debris contracts (i.e. private property debris removal, etc.)
- Provided research assistance and strategic planning thoughts for the development of the Middle Peninsula Debris Management Plan.
- Consulted with New Paradigm President & CEO Evan M. Glassman regarding the use of parametric insurance to cover debris cost associated with storm events not normally covered by FEMA.

The Middle Peninsula/Northern Neck Debris Re-Entry and Access Authorization Plans will improve and support the jurisdictions within the Middle Peninsula/Northern Neck with Operational Coordination, Terrorism Planning, Information Sharing, and Recovery Planning. Re-entry planning is critical to ensure the safe return of citizens to their homes and businesses following an evacuation from a terrorist or natural disaster, while developing a strategy to screen out potential terrorists from infiltrating and taking advantage of a recovery operation.

• Discussed re-entry plan development concepts and rational for plan selection with PDC staff to help shape the development of the Middle Peninsula Re-Entry Plan.

- Reviewed local plan presented by Gloucester County. Accepted by all participating localities (Gloucester, Essex, Mathews, Middlesex, King William, and King & Queen).
- Began to draft Introduction, Purpose, Scope and Approach of plan.
- Began to review localities' Emergency Operations Plans (EOPs) for roles/responsibilities section.

Project 31210 - Emergency Management

Provides funding for the Regional Emergency Planner position based at the Middle Peninsula Planning District Commission (MPPDC). The Regional Emergency Planner supports the Emergency Managers, who do not have planners on staff, in each locality with planning.

- Attended the National Hurricane Conference in New Orleans April 21-26. This conference allowed emergency managers nationwide to learn about how to better mitigate for, prepare for, respond to and recover from hurricanes. Participated in Debris Monitoring; Functional Assessment Support Team (FAST); Emergency Management; and Mental Health Sessions.
- In process of submitting State Homeland Security Program (SHSP) grants. The State Homeland Security Program (SHSP) provides communities funds to enhance our national resilience to absorb disruptions and rapidly recover from incidents both natural and manmade as well as to implement the goals and objectives included in State homeland security strategies and initiatives in their State Preparedness Report (SPR). Activities implemented under SHSP must support terrorism preparedness by building or enhancing capabilities that relate to the prevention of, protection from, mitigation of, response to, and recovery from terrorism in order to be considered eligible. Began drafting the following proposals for submission in June:
 - 1. a proposal for Regional Emergency Manager, which provides partial funding for the Regional Emergency Manager's position at the MPPDC.
 - 2. a proposal to create a Complex Coordinated Terrorist Attack (CCTA) plan, Annex or Threat Hazard Identification Risk Assessment (THIRA). This proposal will be discussed at the May Emergency Managers Meeting.
 - 3. a proposal to revise King William County's Emergency Operations Plan (EOP).

Project 31211 – Gloucester Continuity of Operations Plan (COOP)

The Middle Peninsula/Northern Neck Debris Management Plan improves and supports the jurisdictions within the Middle Peninsula/Northern Neck's Operational Coordination, Information Sharing and Recovery Planning. The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs) identified the need to develop a Regional Debris Removal Plan that would engage the 10 county area in a joint planning process.

- Consulted with Brett Major from Gloucester County Emergency Services regarding COOP Basic plan.
- Continued to receive COOP Departmental Worksheets from localities and incorporated them into plan.






Opportunity Zones Fact Sheet





What are Qualified Opportunity Zones?

Qualified Opportunity Zones are low-income census tracts [IRC Section 45D(e)] that were nominated by the governor of Virginia and certified by the U.S. Treasury where new investments may be eligible for preferential tax treatment if they meet certain qualifications. A low-income census tract is defined as having an individual poverty rate of at least 20 percent or a median family income no greater than 80 percent of the area median income. According to the 2015 and 2016 U.S. Census data, Virginia had 901 eligible census tract, and per the Tax and Jobs Act, Virginia was only able to nominate 25 percent or 212 tracts and could have up to five percent or 11 as contiguous tracts. Virginia nominated 212 out of 901 tracts. The designations are permanent until Dec. 31, 2028.



What are Qualified Opportunity Funds?


- Private-sector investment vehicles that invest at least 90 percent of their capital in Opportunity Zones.
- Must be set up as a partnership or LLC.
- A taxpayer must self-certify on their tax return by completing a form to create an Opportunity Fund. A draft form has been released by the U.S. Treasury.
- Equity investment derived from an investor's capital gains from a prior investment.

What are the benefits from investing in a Qualified Opportunity Zone Business or Property?

- Temporary tax deferral of capital gains reinvested into a Qualified Opportunity Zone Fund. The deferred gain must be recognized on the earlier of the disposition of the investment or Dec. 31, 2026.
- Step-up in basis, which the initial basis in a Qualified Opportunity Zone investment starts at zero. The basis increases by 10 percent with a holding period of five years, and by an additional 5 percent if held for at least seven years, excluding up to 15 percent of the original gain from taxation.
- Permanent exclusion from taxable income of capital gains from the sale or exchange of an investment in an Opportunity Fund if the investment is held for at least 10 years.
 The basis of investment at the time of sale is increased to the fair market value.

What types of initatives can Opportunity Funds be used for?

- Qualified opportunity zone stock acquired after Dec. 31, 2017
- Capital or profits interest in a domestic partnership acquired after Dec. 31, 2017
- Qualified opportunity zone business property acquired after Dec. 31, 2017
- · Qualified opportunity zone business
