September 27, 2023 Saluda, Virginia

I. Welcome and Introductions

The monthly meeting of the Middle Peninsula Planning District Commission was held in the Regional Board Room at the Middle Peninsula Planning District Commission office in Saluda, Virginia on Wednesday, September 27, 2023 at 7:00 p.m. MPPDC Chairman, Chriscoe welcomed everyone in attendance.

II. Approval of July Minutes

Chairman Chriscoe asked whether there were any corrections or changes to the July Minutes. There being no corrections to the Minutes, Chairman Chriscoe requested a motion to approve the July Minutes. Mr. Moskalski moved that the July Minutes be approved. Mr. Meeks seconded the motion; motion carried.

III. Approval of Financial Reports for July & August

MPPDC Chief Financial Officer, Heather Modispaw presented the Financial Reports for July and August and reported project closeout continues. Ms. Modispaw expects to have the final closing entries in October and the final report available at the October Commission meeting. FY23 contracts receivable was \$677,493.00 on June 30th; \$204,130.00 on July 31st; and \$109,539.00 on August 31st. Chairman Chriscoe asked

whether there were any questions regarding the MPPDC financial reports for July and August before being approved subject to audit. There being no questions, Chairman Chriscoe requested a motion to approve the financial reports for July and August subject to audit. Mr. Moskalski moved to approve the financial reports for July and August subject to audit. Mr. Jones seconded the motion; motion carried.

IV. Executive Director's Report on Staff Activities for the Months of August and September

MPPDC Chairman Chriscoe requested MPPDC Executive Director, Lewie Lawrence review the Executive Director's Report on Staff Activities for August and September. The Executive Director's Report on staff activities is developed at a monthly staff meeting, organized by PDC Service Centers, and the activities are used to report grant funding activities.

Mr. Lawrence stated due to the lengthy Agenda, he will just share 3 brief videos of the smaller scale dredging project at Captain Sinclairs utilizing flocculant and geotextile bags. Mr. Lawrence encouraged all in attendance to review the August and September reports and contact him with any questions they may have.

VI. MPA Update

MPA Chairman, Ashley Chriscoe reported he is continuing to determine an agreeable date to reconvene the MPA. MPPDC Executive Director, Lewie Lawrence reported the MPA has received federal funding from the Southeast Crescent Regional Commission (SCRC) which it intends to provide to the MPA so that it can once again offer the small business training course required for small businesses to access the available loan funds MPPDC has to support new and existing businesses in the region. The SCRC is an economic development partnership agency of the federal government and seven state governments which includes Virginia. The SCRC's mission is to build sustainable communities and strengthen economic growth across the Southeast Crescent Region.

IX. <u>Update on Regional Assessment Findings: Gloucester County</u>

MPPDC Chairman Chriscoe introduced Mr. John Atkinson, District Manager of Eagleview. Eagleview provides imagery solutions to State and Local governments for a variety of critical roles, including property tax assessment, GIS data management and mapping, directing emergency responders, managing, and maintaining infrastructure, and helping public safety and emergency management teams plan for, respond to, and recover from disasters utilizing drone technology. Mr. Atkinson provided a presentation

outlining Orthogonal and Oblique Imagery; Viewing and Measurement Software; Assessment Integrations; Third Party Integrations; Analytics Tools for Property Assessment; and Beneficial Use by Multiple Governmental Departments.

MPPDC Chairman Chriscoe introduced Mr. Dan Thomas, Gloucester County Assessor. At the request of the Commission, Mr. Thomas met with the Commissioners of Revenue (COR) of the localities interested in a regional approach over the past few months. The three areas of concern were: a lack of consistency, equity, and accountability; ever-increasing costs; and the dwindling number of reassessment companies. Mr. Thomas provided a presentation reviewing the history of discussions surrounding a regional approach; Overview of concerns regarding quality and accountability; Virginia Code §58.1-3379 and §58.1-3295.1; Duties of a Consultant; Duties of a Regional Reassessment Director; Benefits of an In-house Solution; and Hybrid Options. Mr. Thomas stated a district-wide approach would be more expansive than independent reassessments and discussed the (5) options available for consideration:

- 1. Maintain Current Reassessment Policy The current responsibilities and duties of the Commissioner of Revenue would continue without change and involves no budgetary impact.
- 2. Consolidated Reassessment Contracting Involves a universal contract with one mass appraisal company to serve the 5 Middle Peninsula localities on a rotating basis.
- 3. Hiring a Regional Director Involves hiring an individual to oversee the reassessment process and clerical support staff. This would have a budgetary impact consisting of salaries and benefits, equipment, tech support, and leased office space.
- 4. Rotational Reassessment Staff Involves increasing the two-person staff in Option #3 to an eight person staff that includes four additional appraisers and two additional clerical support staff members. Rent-free office space would be provided to appraisers and possibly one or two clerical support staff by the county during their respective reassessment. This would have a budgetary impact consisting of salaries and benefits for eight employees, equipment, tech support; and leased office space.
- 5. Fully Staffed Regional Reassessment Office Involves the hiring of a full staff including a Real Estate Assessor, a full complement of appraisers, and clerical support staff. This would have a budgetary impact consisting of salaries, automobiles, equipment, tech support, office space fully equipped with a networked computer system utilizing a CAMA software program that would be integrated with the computer systems in each of the participating localities. Benefits would be comparable to other real estate assessment offices in Virginia. This option would be the most expensive of the five options.

At the direction of the Commission, MPPDC Executive Director will continue to share related information and materials. This will also continue to be a topic of discussion at the Local Government Administrators meetings.

X. <u>Local Wetland Board Discussion: Ashley Chriscoe and Special Invited</u> Guest

MPPDC Chairman Chriscoe introduced former King & Queen County Administrator and County Attorney, Tom Swartzwelder who was in attendance via Zoom. It was explained that all development within the tidal and intertidal areas of the Commonwealth requires the submittal of a Joint Permit Application to be reviewed by the Virginia Marine Resources Commission (VMRC) and US Army Corps of Engineers and then is received by the local Wetlands Board. Board members review each application to ensure the applicant is designing their project following all applicable regulations and technical guidance administered by the Planning and Zoning staff. If a permit is required, a public hearing takes place within the locality to allow citizens the chance to comment on the proposal. As requirements become more complex, County staff can become unequipped to efficiently manage the process. Mr. Swartzwelder provided examples of how the time involved in this process is unnecessary and can result in missed financing opportunities for landowners among other challenges. He also explained how during his tenure, the King & Queen County Wetlands Board Ordinance was repealed and the Wetlands Board was disbanded. It was further explained that the biggest inconvenience following these changes was that the applicant must travel to VMRC Board meetings for their public hearing, however many applicants use a paid agent for representation. The travel burden is on the consultant and not the homeowner.

Discussion ensued amongst the Commission with many voicing repeal support for their local Wetlands Ordinance and Wetlands Board. MPPDC Chairman, Ashley Chriscoe stated this topic will be discussed at Gloucester County's next Board of Supervisors Meeting.

XI. General Assembly Budget

MPPDC Executive Director, Lewie Lawrence encouraged all in attendance to review the General Assembly Budget Overview from Advantus Strategies, included in their meeting packet.

Delegate Keith Hodges reported ~\$5B budget surplus; \$250k for Blue Catfish Industries Fund; \$4M Waterway Maintenance Fund; Funding to address healthcare workforce crisis and mental health; and Record funding in education of \$650M. It was noted that issues with the Waterway Maintenance Fund persist and restructuring of the program is needed.

XII. <u>Virginia Department of Conservation and Recreation: Community Flood</u> Preparedness Fund Grants and Loans

MPPDC Deputy Director, Curt Smith reminded the Commissioners the Community Flood Preparedness Fund Round 4 (CFPF) has a total of \$80,000,000 available in loans and grants for Start-Up Funding; Planning & Capacity Building, Studies; and Resilience Projects. The Resilient Virginia Revolving Fund Round 1 (RVRF) has a total

of \$18,500,000 available in loans and grants for non-federal match for federal resilience grants to localities; Hazard Mitigation of Buildings; Capitalization for Local Flood Resilience Programs; and Capacity Building for Local Flood Resilience Funding Programs.

In July, the Virginia Department of Conservation & Recreation released manuals for 30-day public comment. As a result, DCR modified their definition of "community scale". Community Scale projects must now provide flood protection benefits to at least 25% census block. Match requirements for low-income geographic areas have been lowered and the Department will consider match waivers up to \$1M for projects in those areas. Language regarding payback requirements in the event of project failure has been amended in both the CFPF and the RVRF to clarify that project failures due to conditions that exceed normal operating conditions may not trigger this requirement.

Grant/Loan rounds opened at the beginning of September and will close at the beginning of November 2023. At their monthly meetings, local planners were encouraged to submit project ideas. DCR and the Review Committee will evaluate applications in November/early December and awards will be announced in mid-late December.

XIII. Other Business:

2022 Tourism Economic Impact Data: MPPDC Executive Director, Lewie Lawrence drew the Commission's attention to a handout containing the local tourism economic impact data for 2022. All localities, except for King William County, have fully recovered from 2020 expenditures exceeding those in 2019 due to Covid. This data is received quarterly and was shared with the Local Government Administrators via email.

Portadam: MPPDC Deputy Director, Curt Smith provided a handout illustrating a new Fight the Flood participating business, Portadam. Portadam offers flood risk mitigation products which can be used to divert floodwaters away from buildings and key infrastructure. A deployment demonstration was provided on the grounds of the MPPDC office complex after the LGA meeting on September 8th.

VDOT: MPPDC Deputy Director, Curt Smith reported the differences for Round 6 Smart Scale applications includes the development and submission of Pre-scoping Modules for prospective projects prior to November 17th. VDOT Fredericksburg District staff indicated that only half the number of engineers are employed at the District office as compared to what was available during Round 5 and due to these internal staff capacity restraints, each County and PDC in the District may only request District assistance for 3 projects via the Pre-scoping Module in the VDOT Smart Portal. The 3 projects can only include one "new" project which has not previously been applied for and where VDOT engineers have previously not provided designs, cost estimates, etc. and 2 projects which would be re-applications where VDOT engineers only need to make slight modifications and adjustments to existing designs, cost estimates, etc. Anyone wishing to submit more than 3 would need to fund and contract with their own engineer.

Regional Grant Position: Commissioner and Mathews County Board of Supervisors Chairman, David Jones reported his Board has discussed the proposal of a regional grant writer position and has tabled passing a resolution until they receive more solid information. For those who may not have been present at the last Commission Meeting, MPPDC Executive Director, Lewie Lawrence reported a need was expressed by Local Government Administrators for additional staff whose sole responsibility would be to research, apply for, and obtain additional infrastructure awards for the Middle Peninsula region. These would be funding opportunities outside of the service centers the MPPDC submits proposals for on behalf of the Commission. The exact cost to each locality cannot be determined until a coalition of the willing is set. Mr. Lawrence polled the Commissioners in attendance for their interest in creating a regional grant writer position. Gloucester, King & Queen, Middlesex, Mathews Counties, as well as the Towns of West Point and Tappahannock expressed their interest in creating this position. The interest of Essex and King William Counties along with the Town of Urbanna remains unknown.

XIV. Adjournment

Chairman Chriscoe requested a motion to adjourn. Mr. O. Williams so moved, Mr. Moskalski seconded; motion carried.

Project 30186 - Elevated Septic Pilot FY22

Construction of a vertically elevated septic system will occur at the King & Queen Telehealth and Business Development Center as part of a three-year pilot program to `analyze an engineered septic unit that houses and treats all sewage effluent in a vertically elevated, self-contained unit suitable for areas with high water tables and flooding in Coastal Virginia.

- Continued to coordinate with Triangle Environmental regarding designs and structural modifications for elevated septic systems for commercial application at the King and Queen facility.
- Reported that King and Queen County has completed the bid process and is negotiating contract terms
 with selected contractor for the construction of the new facility where the elevated pilot septic system
 will be showcased.

<u>Project 30190 – DCR Flood Fund - Hoskins Creek (Tappahannock)</u>

Project is to design, obtain permits for, and construct a living shoreline on the Town-owned property adjacent to the Rte. 17 bridge over Hoskins Creek in Tappahannock.

- Submit quarterly progress and financial report.
- Continued to prepare to apply for the shoreline permit and continue working towards construction.

Project 30191 - DCR Flood Fund - Mill Creek Boat Ramp (Middlesex)

Project is to design and develop a draft Joint Permit Application for the shoreline and structures adjacent to the boat ramp at the Carlton Road (Mill Creek) public wharf in Middlesex. The designed solution will help mitigate the shoaling of the boat ramp and enhance the overall resilience of the public wharf.

 Continued the review of the draft report prepared by Ingrid Bauer, Senior Associate Engineer Wetland Studies and Solutions, Inc. The report offers multiple solutions to address shoaling at the public boat ramp. Participants in the meeting included, Department of Wildlife Resources, private property owners, VDOT representatives, Middlesex County staff, Middlesex County elected officials, and PDC's staff. Inquired if on-the-ground conditions because of Tropical Storm Ophelia warranted modifications to the report.

Project 30192 – DCR/FEMA - Fight the Flood GIS Tool Enhancements

Improvements will be made to the FTF online and GIS tools which are intended to enhance the GIS data tool capabilities and the overall management of the program. Improvements will include automated programs to expedite and streamline the grant application process, programs for identifying needs and advancing projects which align with available funding resources, improvements which will help feature products and services for participating FTF businesses, and training for MPPDC staff.

- Submit quarterly progress and financial report.
- Continued to update the Regional Living Shoreline Incentive Funding Program survey and the Regional
 On-Site Wastewater Treatment and Disposal Funding Program survey as both will be added to the Fight
 the Flood website.
- Finalized scope of work and contract to Consociate Media for the development of website materials
 featuring FTF business living shoreline products to enhance the educational and interactive experience
 of the website.

- Photographed installation of Fight the Flood solutions at Captain Sinclairs in Gloucester.
- Developed analysis of low-income areas based on the definition provided by VDCR for Round 4 of the Community Flood Preparedness Fund.
- Worked to update status of projects in Fight the Flood. Created tracking for designed, permitted, and
 amount of funding needed to complete projects. This included draft development of survey and
 ARCGIS tools to better manage this data. Created GIS tools to collect data currently contained in
 ARCGIS. Upon compiling this data, it was further refined by reaching out by email and phone to get
 current figures from appropriate participants. This completely up to date information was then compiled
 into a spreadsheet.
- Communicated with a beneficial reuse paver company that has interest in dredge material being used in their products.
- Overall management of the Fight the Flood program this period included 19 administrative tasks, 36 phone calls, and 19 correspondences.

mechanism for transferring title of Commonwealth or private holdings to the Authority; developing appropriate acquisition and site management plan. This Program allows the Authority to function by supporting the individual projects and operations of the Authority, as well as by responding to daily requests for assistance from local government staff.

Project 32021 – PAA GO VA Sea Grant Resilience Economy

Virginia Sea Grant was awarded a GO Virginia award to assist the Middle Peninsula and other coastal areas with developing a water management economy to combat flooding and sea-level rise. This project will utilize land owned by the MPCBPAA as field stations to encourage business innovation in the flood resiliency space.

• Continue to provide assistance to companies such as NARTX when permitting agencies inadvertently and overtly utilize reports provided by science advisors to VMRC that do not contain science or data. The following is an example of a retraction/clarification on product performance issued by VMRC:

Subject: NATRX monitoring

Dear Team,

I've been looped into the discussion related to the distribution of the monitoring report for the NATRX structures, which came about following a boat visit hosted by VMRC in preparation for an upcoming grant application. I'd like to clarify that our visit to the NATRX structures wasn't a full-fledged monitoring trip; rather, it involved a brief observational pass during mid/high tide to gain insights and conduct a visual check post-Ophelia.

During our visit, although we did notice some resettling, we couldn't perform a comprehensive assessment due to the tide conditions. Based on our observations, it appeared that the structures had settled but remained within their original footprints. Furthermore, we could visually confirm that these structures were effectively serving as barriers to wave energy, evident by comparing rack lines and recent erosion between the protected shoreline and the unprotected shoreline.

Subsequent to our visit, I engaged in discussions with Lewie Lawrence and the NATRX company to explore potential design modifications aimed at preventing scouring. I also shared images of similar structure layouts that minimize vertical facing. It's important to note that this project serves as a pilot endeavor for crafting site-specific, adaptable structures within a high-energy environment while minimizing the footprint within submerged aquatic vegetation (SAV) areas.

I'm aware that NATRX structures can be tailored to address site-specific requirements, and the engineers/designers have the flexibility to continually adapt and refine designs to meet stability, aesthetic, fetch, and environmental considerations. Therefore, despite our observations of some settling and the lessons we've discussed, I remain confident that through collaboration and technical

evaluations of test structures the NATRX has the ability to adjust designs based on site-specific demands, ensuring that each project is custom-tailored to the property owner's needs and environmental considerations.

Let's work collaboratively to ensure the success of innovative designs, while also providing constructive feedback to ensure these structures align with the requirements of both regulators and landowners. If you have any additional questions or suggestions, please feel free to reach out.

- Provided training to a group of William and Mary Public Policy students researching permitting challenges associated with water management solutions.
- Attended a Coastal Policy Practicum class taught by Dr. Molly Mitchell and Dr. Sarah Stafford to speak on public trust doctrine and low water property ownerships and barriers to accessing Federal funding.

Project 32024 - MPPDC Virginia Outdoors Foundation (VOF) Get Outdoors

This project will provide the Middle Peninsula Chesapeake Bay Public Access Authority with nature trail demarcation and location services on the Captain Sinclair's complex in Gloucester by partnering with Knott Alone Hold Fast, a veteran support program.

- Continued discussion with Dan Knott, Principle with Knott Alone Hold Fast for trail planning. Provided draft maps and discussed various routes for the trails, including approach for trails. Set meeting date for next trail planning meeting.
- Delivered tractor to Kubota for maintenance prior to trail creation.

One design of a next generation shoreline for a publicly owned property in a high energy wave environment will be completed. Year 2 will involve further development of the whitepaper and a next generation shoreline design for a moderate wave energy publicly owned site.

- Hosted VDCR Director for tour of Middle Peninsula waterfront and coastal resilience project sites on September 20.
- Met with marina owner in Deltaville regarding living shoreline design.
- Assisted Middlesex County citizen with design and financing for living shoreline solution.
- Met with Chesapeake Bay Trust staff to discuss prospects for future MPPDC grant applications for Trust funding.
- Met with DCR SEAS to educate SEAS staff on how to connect Middle Peninsula property owners with the MPPDC Fight the Flood program when SEAS is working to advise local citizens regarding shoreline solutions.
- MPPDC staff is continuing to correspond and work with a Mathews County homeowner who has had a repair permit in hand and 319(h) funds encumbered since May, but their local septic contractor has been purchased by a Massachusetts based company and was a no-show for their July appointment date to install an alternative septic system. Homeowner has already signed a contract and paid a deposit.
- Received a phone call from elderly Middlesex County homeowner on Social Security seeking to be
 reimbursed for an expensive septic repair performed 2 months prior. At this time, MPPDC does not have
 any programs that will reimburse for work already performed. Homeowner was referred to VA DHCD,
 VHDA, SERCAP, Bay Aging, Gloucester Rural Housing, local Churches, and the Department of Social
 Services for possible assistance.
- Received phone call from local septic contractor who offered to post the information of all MPPDC's
 septic grant and loan funding programs on their new website, to better assist Middle Peninsula
 homeowners with affordability.
- Continue to receive phone calls from Middle Peninsula homeowners seeking septic pumpout assistance. To-date, (33) Essex; (10) Mathews; (10) King William; (9) King & Queen; (9) Gloucester; and (18) Middlesex County homeowners are on the waiting list for when septic pumpout funding becomes available.
- MPPDC staff received phone calls from (6) Middle Peninsula homeowners in need of septic assistance under the 319(h) grant program. (1) King & Queen; (3) Gloucester; (1) Mathews; and (1) Middlesex County.
- To-date, (5) Alternative Septic Systems in Mathews County have been installed; (1) Conventional Septic System in Gloucester County has been repaired; (2) Septic Systems in Middlesex County, (2) in Gloucester County, and (2) in Mathews County have been pumped out under the 319(h) grant program. All 12 homeowners were approved and reimbursed 50% of the average practice cost set DEQ. Funding is currently encumbered for the installation of (3) Alternative Septic Systems and (1) Septic Pumpout in Mathews County.
- MPPDC staff screened 8 homeowners on Gwynn's Island in Mathews County for septic repair/replacement assistance under a grant funded by the Mathews Community Foundation to assist LMI homeowners on Gwynn's Island. One homeowner's project qualifies for 50% grant assistance.
- Overall management of the Fight the Flood program this period included 19 administrative tasks, 36 phone calls, and 19 correspondences.

Project 32176 - NFWF Veterans Partnership

MPPDC will develop and formalize an operating agreement between the MP-PAA and Knott Alone-Hold Fast, Inc, a nonprofit organization providing counseling and coastal eco and restoration workforce development services focusing on leveraging Chesapeake Bay coastal environs for veterans. The project will build capacity to address a known gap in local workforce for resilience and restoration activities.

Gloucester County was awarded VA Port Authority Waterway Maintenance Funding to dredge the Aberdeen Creek channel to –7 feet Mean Low Water and place the dredged material at an upland disposal site. MPPDC is administering the grant on behalf of the County with procurement and permitting assistance and project oversight.

- Continued to research dredge material disposal options and will reconvene to meet with the County and DCR in the near future. Develop a list of landowners willing to consider placing material along the shoreline to protect shoreline. Project 30198 - Gwynn's Island Septic

To support the MPPDC Regional On-Site Wastewater Treatment and Disposal Funding Program, this grant from Mathews Community Foundation provides septic repair assistance to LMI homeowners on Gwynn's Island.

• As of October 13, MPPDC staff has income qualified 1 of 8 potential homeowners and continues to screen septic assistance inquiries for eligibility to receive financial assistance through this grant program provided by the Mathews Community Foundation. The physical addresses of each of these septic

systems were entered into the mapping tool to verify their location is within the program's target area, Gwynn's Island.

- Met with MPPDC Executive Director to discuss programmatic questions regarding combining 319(h) and Gwynn's Island grant funding to assist elderly Mathews County homeowner. Homeowner is qualified for 50% grant funding.
- Contacted Farmer's Septic and requested estimate for Mathews County homeowner's septic repair/replacement project.
- Received estimate from Farmer's Septic via email for Mathews County homeowner's septic repair/replacement project. Project cost is estimated at \$28,505.00. Homeowner's income qualifies for 50% grant funding assistance.
- Received request from Farmer's Septic to share MPPDC septic repair/replacement assistance program information on their new website.
- Received email from Mathews County homeowner stating their property will need to be surveyed in mid-November before they can apply for a repair permit. Reminded homeowner funds are first-come, first-served and cannot be encumbered until a repair permit has been received.
- Contacted Farmer's Septic with questions regarding Mathews County homeowner's septic
 repair/replacement project. AOSE, Larry Madison required a land survey be performed as the property
 line wasn't clear enough to complete the design. Discussed the potential effect the current project
 timeline may have on available funding.

Project 32163 - DEQ 319(h) NPS IP for BMP Residential Septic 2021

This project provides cost-share assistance to landowners, homeowners, and agricultural operators as an incentive to voluntarily install nonpoint source (NPS) best management practices (BMPs) in designated watersheds.

- As of September 30, MPPDC staff has received phone calls from 161 homeowners in Gloucester, Mathews, and Middlesex Counties in response to the press release for available 319(h) funding. The physical addresses of each of these septic systems were entered into the mapping tool to verify their location is within the program's target areas. (58) homeowners had miscellaneous requests, declined moving forward, requested ineligible practices such as voluntary upgrades and reimbursement for work completed prior to program launch; (6) Mathews County homeowners placed their project on hold; and (75) homeowners' septic system isn't located in the program's target area. To-date, (5) Alternative Septic Systems in Mathews County have been installed; (1) Conventional Septic System in Gloucester County has been repaired; (2) Septic Systems in Middlesex County, (2) in Gloucester County, and (2) in Mathews County have been pumped out. All 12 homeowners were approved and reimbursed 50% of the average practice cost set DEQ. Funding is currently encumbered for the installation of (3) Alternative Septic Systems and (1) Septic Pumpout in Mathews County.
 - (4) Homeowners remain on the Septic Pumpout list. (3 Mathews, 1 Middlesex)
 - (7) Homeowners remain on the Septic Repair/Replacement list. (6 Mathews, 1 Middlesex)
- Continue to receive inquiries from King William, King & Queen, and Essex County residents seeking
 septic assistance and are not in the designated target area set by DEQ to be eligible for 319(h) septic
 reimbursement funding. When applicable, these inquiries are screened for interest and eligibility in other
 MPPDC program funding, referred appropriately to VA DHCD, VHDA, and SERCAP for possible
 septic repair/replacement assistance and those seeking septic pumpout assistance are placed on the
 waiting list for when funding becomes available.
- Met with MPPDC Executive Director to discuss programmatic questions regarding combining 319(h) and Gwynn's Island grant funding to assist elderly Mathews County homeowner with a failing septic system. Homeowner is qualified for 50% Gwynn's Island grant funding.

- Received email requesting address verification from Mathews County homeowner interested in
 obtaining 319(h) assistance with septic repair/replacement. The address of the homeowner's septic
 system wasn't in the target area set by DEQ. Email was forwarded to MPPDC Coastal Resilience
 Planner for SWAP eligibility and CFO for possible loan funding.
- Contacted Farmer's Septic and requested estimate for Mathews County homeowner's septic repair/replacement project.
- Received estimate from Farmer's Septic via email for Mathews County homeowner's septic repair/replacement project.
- Received request from Farmer's Septic to share MPPDC septic repair/replacement assistance program information on their new website.
- Received phone call from Farmer's Septic requesting address verification of Mathews County homeowner in need of assistance with their septic repair/replacement project. The same address had been received by the homeowner via email two days prior. The address of the septic system isn't in the target area set by DEQ.
- Received email from Mathews County homeowner stating their property will need to be surveyed in mid-November before they can apply for a repair permit. Reminded homeowner funds are first-come, first-served and cannot be encumbered until a repair permit has been received.
- Contacted Farmer's Septic with questions regarding Mathews County homeowner's septic
 repair/replacement project. AOSE, Larry Madison required a land survey be performed as the property
 line wasn't clear enough to complete the design. Discussed the potential effect the current project
 timeline may have on available funding.
- Received voicemail from son of Mathew's County homeowner interested in 319(h) septic repair/replacement assistance for his mother.
- Received phone call from frustrated Mathews County homeowner providing an update on their septic
 repair/replacement project. Homeowner has had 319(h) funds encumbered since May and reported
 ChurchView Septic/Wind River Environmental, missed their July septic repair/installation date, and
 now assures their project will be completed in October. According to homeowners, communication and
 customer service has suffered since locally owned ChurchView Septic was purchased by the
 Massachusetts based company.

Requested more information on our assistance programs to apply for after the estate is settled. - Uploaded information related to Gloucester County homeowner's septic pumpout into the DEQ BMP Warehouse as part of reporting requirements. Received confirmation of receipt from DEQ.
- Received revised estimate for septic repair/replacement project from Mathews County homeowner via email.
- Responded to Mathews County homeowner's email confirming receipt of estimate and informed them MPPDC CFO is working on their loan application. Requested repair permit be submitted as soon as it becomes available to proceed with next steps and encumber funding.

- Received phone call from King & Queen County homeowner interested in obtaining 319(h) assistance with septic pumpout. The address of the homeowner's septic system wasn't in the target area set by DEQ. Homeowner was added to the septic pumpout waiting list as requested.

- Returned phone call from Gloucester County homeowner requesting 319(h) septic repair/replacement assistance and left voicemail requesting the physical address of the septic system.

 referred to MPPDC Coastal Resilience Planner for SWAP eligibility.
- Submitted Quarterly Report to Madison Whitehurst, DEQ TMDL NPS Data Coordinator.
- Received phone call from Gloucester County homeowner requesting 319(h) septic pumpout assistance.
 Address of the septic system is not in the target area set by DEQ. Homeowner was added to the septic pumpout waiting list as requested.

Project 32173 VDH Septic Well Assistance Program (SWAP)

This project will provide grant funding to assist VDH approved low-income Middle Peninsula homeowners with costs associated with septic repair/installation, private well installation/abandonment, and connecting to public water and sewer for the purposes of wastewater/water improvements.

- As of October 13, MPPDC staff have received inquiries from (51) Middle Peninsula homeowners in need of well and/or septic repair/replacement assistance. Homeowners begin the intake/application process for SWAP assistance at the MPPDC. Staff have received (18) complete applications. Staff have collected and submitted (17) homeowners' income documents for verification by Local Health Department Staff to verify the applicant's income is at or below 200% FPG. To date (15) applicants have been low income verified, (1) applicant has not submitted adequate income documentation, (1) applicant is awaiting income verification by the LHD, and (1) applicant has been found to be over income and not eligible for SWAP funds and was referred to other resources. MPPDC Staff has worked with LHD staff generating permits for (13) applicants projects: (1) applicant's project was denied LHD permits and will need private design; (2) applicants have been submitted to the LHD for permits; (1) project isn't eligible for the program; (1) hasn't progressed to permitting; (1) applicant's project has moved to notice to proceed; (3) are pending review of bids for notice to proceed; and (2) are currently open for bids. MPPDC staff continues to move qualified and permitted homeowner's projects into procurement.
- Management of SWAP LP included performing (28) administrative tasks, (28) phone calls, and (35) correspondences.
- To-date, applications have been received from (4) Gloucester, (5) Essex, (3) King William, (2) Mathews, (3) King and Queen, (1) Middlesex County households.

Project 32178 VDH Septic Well Assistance Program (SWAP) Direct to Partner Initiative (D2PI)

This project will utilize American Rescue Plan Act Funding (ARPA) through the SWAP Program to expedite the installation and completion of ~5 VDH approved Middle Peninsula low-income homeowner's shovel-ready septic, sewer, and well installation projects for the purposes of wastewater/water improvements.

• As of October 13, (1) project has received a bid and is under review for a notice to proceed; (3) projects

are currently posted for bid solicitation; and (1) project needs a solution for shoreline erosion but first requires a survey be performed. The project is currently posted for bids for a survey.

• Management of SWAP D2PI included performing (12) administrative tasks, (10) phone calls, and (26) correspondences.

Project 32179 DEQ ARPA Septic Local Partner Program

This project will utilize American Rescue Plan Act Funding (ARPA) through the Virginia Department of Environmental Quality to utilize a new and more cost-effective septic repair pilot program approach for participating Middle Peninsula homeowners with failing septic systems.

• Continued to consult with DEQ staff, Lauren Linville and Lars Bolton concerning the recently awarded, DEQ Septic Local Partners Program and the draft of the MPPDC Program Design. Awaiting DEQ review and approval of submitted re-draft document.

MPPDC agreed to service Middle Peninsula Business Development Partnership's (MPBDP) Small Business Loan Portfolio after MPBDP's dissolution November 30, 2011. MPPDC established a revolving loan fund and staff initiate ACH loan payments from clients' bank accounts and manages the accounts. Principal repaid will be held until the Commission determines the best use for these funds as allowed by the USDA (RBEG) original lending restrictions. Interest earned will be used to offset administration costs.

- Funds available \$147,105
- MPPDC received notice of award for Southeast Crescent Regional Commission funding to hire the required business training course trainer and allow for reactivation of the loan fund.

<u>Project 32177 – EDA Technical Assistance Program</u>

MPPDC will facilitate the maintenance, update, and implementation of the Middle Peninsula Comprehensive Economic Development Strategy (CEDS) utilizing existing regional partnerships and building upon recent and ongoing regional initiatives focusing on fostering economic growth within the region.

- Continued updating the CEDS plan including expansion of the plan's economic resilience section.
- MPPDC received notice of award for Southeast Crescent Regional Commission funding to hire the required business training course trainer and allow for reactivation of the loan fund.
- Worked to identify status of projects in FTF. Created tracking for designed, permitted, and amount of
 funding needed to complete projects. This included draft development of survey and ARCGIS tools to
 better manage this data. Created GIS tools to collect data currently contained in ARCGIS. Upon
 compiling this data it was further refined by reaching out by email and phone to get current figures from
 appropriate participants. This completely up to date information was then compiled into a spreadsheet.

- Communicated with a beneficial reuse paver company that has interest in dredge material being used in their products.
- Overall management of the Fight the Flood program this period included 19 administrative tasks, 36 phone calls, and 19 correspondences.
- Submitted a NOAA Climate Resilience Challenge letter of intent requesting \$25 M in partnership with VA Sea Grant to assist with further development and expansion of the Water Management and Coastal Resilience Industry within the Middle Peninsula.
- Managed site assessment and planning activities for the Town of West Point-owned property adjacent to the Middle Peninsula Regional Airport. The site is being developed as a key location for supporting new and expanded businesses focusing on water management and coastal resilience activities.
- Launched development of nine DCR Flood Fund and Resilient Virginia Loan Fund Round 4 proposals. Applications due November 12.

Project 321771- GO Virginia – West Point Adjacent Land Airport Study

Project studies the needs for moving the land adjacent to the airport to the next tier under the VEDP site readiness program.

• MPPDC staff is continuing procurement development to start the project.

Project 321772 - DCR Flood Fund - West Point Bridge Study

Project is to conduct a Hydrologic and Hydraulic Study and Structural Design and Level of Service Study to address ongoing flooding for a Town owned bridge adjacent to the Middle Peninsula Regional Airport.

• MPPDC staff is continuing procurement development to start the project.

LOCAL INITIATIVES

Funding – local dues, PDC base-funding from VDHCD and/or MPPDC General Fund. Funding for specific projects may come from a locality requesting assistance.

Project 30184 - Tappahannock Comprehensive Plan & GIS Mapping

Technical assistance for reviewing and updating data in the Town Plan and digitizing with GIS and printing the Town Zoning and Land Use maps.

Project is closed.

<u>Project 38024 – FY24 Local & Regional Technical Assistance</u>

This program responds to daily requests for technical assistance which other commission programs are unable to provide.

- Coordinated with member jurisdictions staff regarding project needs which funding can be sought by new MPPDC staff positions focusing on seeking Federal Infrastructure funding opportunities.
- Drafted and submitted a pre-application to FEMA's Flood Mitigation Assistance (FMA) program to elevate the pool house on the Captain Sinclair Recreational Area Property.
- Drafted and submitted a pre-application to FEMA's Building Resilient Infrastructure and Communities (BRIC) program to explore legal questions associated with low-water states receiving federal and state funding for the implementation of resiliency projects.

HOUSING

Funding - Housing Loan Program Income

Project 30187 – VHDA Affordable Workforce Housing Development

The three-year project will involve planning, designing, and constructing approximately ten affordable workforce housing units on property owned by the Middle Peninsula Public Access Authority. The project goals involve creating resilient and safe housing for citizens who need to live and work on or near the water. The

designs will involve long-range planning for increased flooding and sea-level rise where the units can be readily moved once a site becomes unsafe for continued residential use.

- Continued to work with Virginia Department of Health, Gloucester County, and Dominion Energy on various septic and right or way permits issues.
- Construction plans & bid documents of the tiny homes & Pool House addition are complete & remain under County review.
- Bid documents for the Main House renovation are complete & ready for bid once the CBPA approval & VDH permits are finalized.

Project 300132 - Energy Efficiency and Conservation Block Grant (EECBG) Revolving Loan Fund

The program emphasizes a community-based approach to help meet energy and climate protection goals. MPPDC was awarded a contract to provide weatherization renovations to 12 homeowners ineligible for LMI weatherization programs in each of the 6 counties. MPPDC subcontracted the promotion and construction portions of this project to Bay Aging but was tasked with administering the overall project. MPPDC is administering the revolving loan program per DMME.

• *Funds available – \$45,942*

EMERGENCY SERVICES

Funding – VDEM/FEMA/Homeland Security

Project 32180 – FEMA Ware Cove

This project is for the mitigation reconstruction of a residential structure in Gloucester County. The current structure will be demolished and a smaller, more code-compliant and more hazard-resistant structure on an elevated foundation system will be constructed. The mitigation reconstruction project will mitigate for flood risk and the associated costs.

 Coordinate with FEMA regarding procurement so MPPDC legal can develop appropriate bid documents.

LOAN FUNDS FOR SEPTIC AND LIVING SHORELINES Funding – VRA

<u>Project 30420 – On-Site Technical Guidance Assistance and Loan Program</u>

The On-Site Technical Guidance Program aids the Middle Peninsula localities and residents in the technical understanding and implementation of approaches to address On-Site Disposal Systems and improve water quality by assisting local homeowners with repairing failing septic systems through low-interest loans and/or grants. In addition, MPPDC received funding under the Water Quality Improvement Fund (WQIF) to provide grants to low-to-moderate income Middle Peninsula and New Kent County homeowners to repair failing septic systems impacting water quality and health in the region. Grants can be paired with loans from the MPPDC Onsite Wastewater Revolving Loan Fund to provide matching funds as required. It is anticipated this funding will be used to provide assistance to 20-27 homeowners.

- Continued to work with various clients interested in loan financing for septic repair.
- Continued to work with clients who have closed on their loans but are waiting for their project to be complete.
- Remaining uncommitted septic repair funds: \$25,283 in loan funds \$21,641 in grant funds.

Project 31500 – Living Shoreline Loan Program

The MPPDC Living Shoreline Incentive Program Loan Fund provides low interest loans to local homeowners to implement living shorelines. These funds will be used for erosion prevention and water quality control and to protect and enhance natural shoreline habitats using strategically placed plants, stone, sand fill and other structural and organic materials.

• Remaining uncommitted living shoreline funds: \$0

Project 33001 – Loan Fund Program for Septic and Living Shoreline

During 2022, the MPPDC received a \$3M line of credit for living shoreline and septic repair projects from the VA Resources Authority. The fund provides a single financing program for activities historically covered by the MPPDC's On-Site Technical Guidance and Living Shoreline Incentive Programs.

- Continued to work with various clients interested in loan financing for septic and living shoreline.
- Submitted quarterly Loan Aging Report to VRA.
- Remaining uncommitted funds: \$2,130,831 in loan funds \$300,000 in grant funds.

Closed Projects

Project 30194 - RAFT Dupont LMI Pumpouts

This project will provide grant funding to ~55 LMI Middle Peninsula homeowners to assist them in complying with the Chesapeake Bay Preservation Act requirement to have their septic tanks pumped out or inspected every 5 years.

<u>Project 30219 – Commuter Assistance Program (CAP) Operating FY23</u>

This program assists local commuters and employers with transportation issues. The main emphasis is on lowering the number of single occupancy vehicle commutes within and from the Middle Peninsula region through marketing and promotion of the program through local media and provision of ride matching services to commuters.

Project 30320 – Rural Transportation Planning FY23

This program provides rural transportation planning services through the Rural Transportation Planning Work Program which outlines specific tasks and goals to guide the rural planning of transportation services.

Project 30428 – On-Site Technical Guidance Assistance and Loan Program

The On-Site Technical Guidance Program aids the Middle Peninsula localities and residents in the technical understanding and implementation of approaches to address On-Site Disposal Systems and improve water quality by assisting local homeowners with repairing failing septic systems through low-interest loans and/or grants. In addition, MPPDC received funding under the Water Quality Improvement Fund (WQIF) to provide grants to low-to-moderate income Middle Peninsula and New Kent County homeowners to repair failing septic systems impacting water quality and health in the region. Grants can be paired with loans from the MPPDC Onsite Wastewater Revolving Loan Fund to provide matching funds as required. It is anticipated this funding will be used to provide assistance to 20-27 homeowners.

Project 31212 - Middle Peninsula All-Hazards Mitigation Plan Update Yr2

MPPDC staff will work with participating localities to update the 2016 All-Hazards Mitigation Plan (AHMP). The plan will address mitigation of several natural hazards impacting the region.

Project 32019 - Sinclair's Public Fishing Pier

The MPCBPAA has contracted the MPPDC to administer a grant from the VA Saltwater Recreational Fishing Development Fund to rehabilitate the public fishing pier at the Captain Sinclair's Recreational Area, which had fallen into a state of disrepair. The project will consist of procuring a qualified contractor to rebuild a traditional wooden framed open pile 400-feet long public use fishing pier that will provide year-round opportunities for saltwater fishing and recreational viewing.

Project 38023 – FY23 Local & Regional Technical Assistance

This program responds to daily requests for technical assistance which other commission programs are unable to provide.

Project 30123 – Staff Support to Middle Peninsula Alliance (MPA) FY23

MPPDC staff are providing clerical and fiscal assistance to the Middle Peninsula Alliance.

MPPDC: Membership, Appointments, Committee Assignments, and Networks

Coastal Policy Team (CPT): The CPT, whose members and alternates represent the Virginia Coastal Zone Management Program's key partners and eight planning district commissions, provides a forum for discussion and resolution of cross-cutting coastal resource management issues. Members serve on the team at the discretion of their agency or planning district commission director. The CPT recommends funding levels to the DEQ Director for coastal zone management projects. (MPPDC Staff 15 years +)

Virginia Coastal Resilience Master Plan Technical Advisory Committee: As appointed by the Governor in EO-71, a Technical Advisory Committee (TAC) with representatives of state agencies, coastal planning districts and regional commissions, and academic advisors, among others will facilitate the coordination and the development of the Virginia Coastal Resilience Master Plan. The Commonwealth's Chief Resilience Officer, Special Assistant to the Governor for Coastal Adaptation and Protection, and TAC will work with localities, regional entities, citizens, and stakeholder groups to identify critical infrastructure, at-risk communities, adaptation strategies, and specific resilience projects for inclusion in the Plan.

Congressman Robert Wittman's Fisheries Advisory Committee and Environmental Advisory Committee: (MPPDC Staff 8 years +) Virginia Sea Grant Program External Advisory Committee (EAC): The EAC provides stakeholder input on the strategic planning process, the research proposal review process, and on Commonwealth-wide trends and needs. The EAC is a diverse group of end-users including representatives from state agencies, the education community, coastal planning and management, the private sector, and NGOs. (MPPDC Staff 9 years+)

The Association for Commuter Transportation (ACT) (Telework Council Secretary): ACT is the premier association for professionals and organizations whose focus is the delivery of commuting options and solutions for an efficient transportation system. The Telework Council is concerned with promoting telework and providing telework information and technical assistance to employers (MPPDC Staff 10 years+)

The Coastal Society: The Coastal Society is an organization of private sector, academic, and government professionals and students. The Society is dedicated to actively addressing emerging coastal issues by fostering dialogue, forging partnerships, and promoting communications and education. (MPPDC staff serves as a Director)

Virginia Shoreline Working Group: The Virginia Coastal Zone Management Program launched the working group in 2022 to focus in on complex regulatory and legal matters pertaining to shoreline management and to help advance shoreline protection and habitat restoration projects that can compete for federal funding.

Virginia Bay Enhancement Working Group (BEWG): The Northam Administration and VMRC launched BEWG in 2020 as result of administration policy of no future overboard discharge of dredged material. The group is tasked with identifying beneficial reuse opportunities for the 1 Million cubic yards of material that is dredged every 3-5 years from the York Spit Navigation Channel which is the primary shipping channel for the Baltimore Harbor in the southern section of the middle of the Chesapeake Bay. MPPDC staff were requested to serve to evaluate alternatives from around the Bay and including the Middle Peninsula.

Government Finance Officers Association (GFOA): The Government Finance Officers Association (GFOA), founded in 1906, represents public finance officials throughout the United States and Canada. The association's more than 20,000 members are federal, state/provincial, and local finance officials deeply involved in planning, financing, and implementing thousands of governmental operations in each of their jurisdictions. The purpose of this letter is to request that you include additional state funding for regional planning district commissions (PDCs) in the FY25/26 budget that you will introduce to the General Assembly's money committees in December.

In your remarks to the joint money committees on August 23, you spoke of your Administration's "culture of striving to improve, of carving out pockets of savings.....empowers more investments to increase the effectiveness of government." Planning district commissions are critical components of the work that the state and local governments do to promote and provide efficient and effective services on a regional basis. Indeed, PDCs are charged with doing just that under the Regional Cooperation Act (15.2-4207), "to encourage and facilitate local government cooperation and state-local cooperation in addressing on a regional basis, problems of greater than local significance."

Each of the 21 PDCs in Virginia is unique. While all are active in spearheading affordable housing development, many serve as strategic and administrative partners in implementing economic development and rural broadband expansion projects. Others guide oversight and administrative services for their GO Virginia region, trigger tourism enhancement, and facilitate actions that protect the Chesapeake Bay and our other natural resources. What they share is their experience and expertise in convening, cooperating, and collaborating with these other partners to facilitate the "recognition and analysis of regional opportunities and take account of regional influences in planning and implementing public policies and services."

In performing these duties, PDC's have been challenged by the adequacy of resources to carry out these functions, or at the expense of other worthwhile projects that assist the state and local governments. Accordingly, we respectfully request your consideration of increasing state funding for PDCs in the next biennial budget by \$150,000 per PDC.

As I am sure you are aware, PDCs have been vital partners for effective and efficient state and local government, providing critical services to the state through implementing state programs and administering statewide processes in collaboration with state agencies. Unfortunately, previous Administrations have not recognized the value of PDCs, and so PDCs remain challenged to provide greater support and assistance in part due to inconsistency in state funding. Funding for PDCs remains

below the level provided in FY2006, with the amount of state support for our three largest PDCs having fallen much further behind. To further illustrate this point, please see the chart below:

PLEASE SUPPORT ENHANCED STATE FUNDING for PLANNING <u>DISTRICT COMMISSIONS</u>

Background:

The Virginia Association of Planning District Commissions is seeking to increase state funding for Planning District Commissions (PDCs) by \$150,000 per PDC (total funding request of \$3.15 million per fiscal year in both FY25 and FY26). The amount requested for inclusion in the governor's introduced budget (to be submitted in December) would extend PDC staff capacity to assist the State on joint work; to execute regional projects and plans; and to help create more efficiencies in how local citizens are served.

Rationale:

- >State funding for PDCs remains below the \$90,000 per year level (for most PDCs) provided in FY2006, with the amount of state support for our three largest PDCs having fallen much further behind previous amounts.
- >State and federal agencies rely on PDCs to convene key players and to administer and broker key local and regional projects of importance to the State; this requires a core competency that has had stagnant funding the past 15 years.
- >With an unprecedented amount of federal grant funding being available, additional resources for PDCs will help bring these dollars to the State and regions.
- >The State benefits from the key activities performed by PDCs in working cooperatively to address/administer state programs and assist state agencies with statewide planning processes.

Summary:

<u>WHAT</u>: Request for additional state funding for PDCs to be included in the next state budget. <u>HOW MUCH</u>: \$150,000 per PDC in both FY25 and FY26.

<u>WHY</u>: To increase PDC capacity to secure federal dollars, to push collaborative projects and to assist the State.
