MIDDLE PENINSULA PLANNING DISTRICT COMMISSION July 25, 2018 Saluda, Virginia

I. <u>Welcome and Introductions</u>

The monthly meeting of the Middle Peninsula Planning District Commission was held in the Regional Board Room at the Middle Peninsula Planning District Commission office in Saluda, Virginia on Wednesday, July 25, 2018, at 7:00 p.m. MPPDC Chairman Thomas Swartzwelder welcomed everyone in attendance.

II. <u>Approval of June Minutes</u>

Chairman Swartzwelder asked whether there were any corrections or changes to the June Minutes. There being no corrections to the Minutes, Chairman Swartzwelder requested a motion to approve the June Minutes. Ms. Conner moved that the June Minutes be approved. Mr. Chriscoe seconded the motion; motion carried.

III. Approval of June Financial Report

Chairman Swartzwelder asked whether there were any questions regarding the June financial report before being approved subject to audit. There being no questions, Chairman Swartzwelder requested a motion to approve the June

financial report subject to audit. Mr. Rivara moved to approve the June financial report subject to audit. Mr. Chriscoe seconded the motion; motion carried.

IV. Executive Director's Report on Staff Activities for the Month of July

Chairman Swartzwelder requested MPPDC Executive Director, Lewie Lawrence review the Executive Director's Report on Staff Activities for the month of July. The Executive Director's Report on staff activities is developed at a monthly staff meeting, organized by PDC Service Centers, and the activities are used to report grant funding activities.

Mr. Lawrence directed Commissioners' attention to several items:

- Discussed "Insurance Program" requirements with Gloucester homeowner and contractor. Received notice from contractor that the failure was more that of the installation and grid system used than the plants. Contractor intends to correct deficiencies and recommends MPPDC wait on settling claim with homeowner and consider extending insurance program from date of new installation. Homeowner agreed and will provide completion statement. Mr. Lawrence reported the contractor has offered to correct the deficiencies at his cost.
- Prepared and submitted proposal for additional \$250,000 VCWRLF funds to capitalize MPPDC Living Shoreline Incentive Revolving Loan Program. Mr. Lawrence reported staff is waiting to hear back.
- Corresponded with Steve Living, Virginia Department of Game & Inland Fisheries regarding new signs at local boat ramps and he provided the following response:

"Thank you for contacting us with your concerns regarding the change in allowed uses at some of the Department of Game & Inland Fisheries (DGIF) Boating Access piers. Our boating access facilities are constructed to allow for the launching and landing of watercraft. They were designed to allow boaters to tie up and load and unload boats. In the past, we have allowed fishing from some of our Boating Access piers. Recent incidents at our boating access facilities have made it clear that we cannot safely allow fishing from our Boating Access piers. We cannot equip them with required safety features such as railings, without interfering with the intended use of the facility to launch and land boats. DGIF does maintain a number of fishing piers as do some localities. These purpose-built structures allow anglers to engage in fishing safely and conform to all relevant safety and building codes in a way a Boating Access pier simply cannot. The majority of our Boating Access sites offer at least some bank fishing opportunities. In addition, the DGIF will continue to evaluate existing fishing opportunities and seek to establish new fishing piers where demand and budgets indicate. I appreciate that the loss of use of the Boating Access pier for angling is frustrating for those who have come to rely on them. As an Agency, our first obligation must be the safety of our constituents as we seek to provide access to Virginia's natural resources".

Mr. Lawrence stated he followed up with the Department of Game & Inland Fisheries and inquired as to the number of "incidents" reported within the Middle Peninsula facilities. No incidents have been reported in the MP to

date but several fatalities have taken place at other sites. Mr. Lawrence asked DGIF to consider working with MP localities to find a solution.

- Toured the Oyster Company of Virginia high pressure processing oyster equipment located in Topping. The HPP equipment opened 200 oysters in 3 minutes with no shell damage and maintained 100% of oyster nectar. The machinery uses 65,000 pounds per square inch to pressure open oyster. Mr. Lawrence provided the Commission with video footage and stated this method opens 60,000 oysters in a day.
- Attended a meeting called by Sen. Lynwood Lewis concerning the Virginia waterways Management Fund to review the draft guidelines for the new dredging grant application program developed by the Virginia Port Authority. Suggested modifications to grant language to better match the needs of Rural Coastal Virginia. Mr. Lawrence presented the Commission with the adopted Resolution and Guidelines Administering the Virginia Waterway Maintenance Grant Program which took effect July 24th. Mr. Lawrence stated this program is 100% with no match required and encouraged everyone to apply.
- Reviewed the USCG report of Virginia's Channels in regards to the MPPDC area and incorporated the report and the Waterway Maintenance Fund. Included in LRTP update and Local Planners Meeting in June. Mr. Lawrence reported there will be a new chapter added relating to dredging and maritime issues.

V. <u>MPCBPAA Update</u>

Mindy Conner, Chairman of the MPCBPAA stated the Authority did not meet this month.

VI. <u>MPA Update</u>

In the absence of Travis Moskalksi, MPA Chairman, Lewie Lawrence, MPA Secretary provided the Commission with an update on the recent activities of the MPA. At its last meeting, the MPA continued to discuss creating a second-tier advisory group to implement the work of the MPA Board and also discussed the criteria for which an entity comes under the Freedom of Information Act. The total amount of government/public funding received by the MPA to date as opposed to private funding determines the MPA is subject to the Freedom of Information Act and as such, the MPA has now gone from a private entity to public.

VII. <u>Public Comment</u>

None.

VIII. <u>VEDP Rural Focus, Christy T. Morton, Vice President, External</u> <u>Affairs, Virginia Economic Development Partnership</u>

Christy Morton, VEDP's VP of External Affairs, gave a PowerPoint presentation on Economic Growth Opportunities in the Middle Peninsula. Highlights included Declining Economic Growth in Virginia, Regionally and Statewide: Findings from the McKinsey-IBM Economic Growth Strategy; Major Opportunities to Spur Economic Growth in Middle Peninsula. Ms. Morton spoke specifically about big initiatives focusing on rural development. Virginia's rankings have declined during the last twenty years which affects the ability to attract business to the Commonwealth. VEDP understands what the problems are and has devised a strategic growth program. Strengths and weaknesses were identified and VEDP is working with GO Virginia and DHCD to compare regional and strategic plans and come up with a partnership. Rural stakeholders from across the Commonwealth have worked together to come up with a rural marketing initiative highlighting all the attributes rural Virginia has for a marketing campaign. Recommendations were Rural Marketing; Ubiquitous Broadband; Expanded Site Inventory; Customized Workforce; Partnerships to fund projects; Tax incentive changes; Community Competitiveness; Civic Leadership.

IX. <u>General Discussion on Go Virginia and WIP 3 Economic</u> <u>Development</u>

Lewie Lawrence, Executive Director provided a handout and reviewed possible water quality-economic development opportunities for new business associated with in-water, near shore, riparian, and upland areas that can drive traditional and new innovative rural coastal business opportunities.

X. Adoption of MPPDC FY19 Indirect Cost Allocation Plan

The Commission was provided with the MPPDC FY19 Indirect Cost Allocation Plan which is based on the budget figures adopted by the Commission in May 2018. The Indirect Cost Allocation Plan enables the Commission to charge funding sources for indirect personnel costs including salaries and fringe benefits as well as overhead costs such as facility expenses, supplies, professional development, certain shared consultant and contractual fee expenses, travel expenses and other miscellaneous expenses such as postage and printing/duplicating. The rates are also used by staff in preparing grant proposals. The FY19 Planned Indirect Cost Rate is 54.86% and the Fringe Rate is 32.66%. Mr. Hollberg motioned to support the MPPDC FY19 Indirect Cost Allocation Plan as presented. Ms. Conner seconded. The motion carried.

XII. Adjournment

Chairman Swartzwelder requested a motion to adjourn the meeting. Mr. Holberg motioned to adjourn; Mr. Chriscoe seconded. The motion carried.

Project 30502 Water Supply Planning

9 VAC 25-780 establishes a planning process and criteria that all local governments will use in the development of local or regional water plans. The plan will be reviewed by the Department of Environmental Quality and a determination will be made by the State Water Control Board on whether the plan complies with this regulation. Within five years of a compliance determination by the board, the plan will be reviewed to assess adequacy and any significant changes will require the submission of an amended plan and review by the board. All local programs will be reviewed, revised, and resubmitted to the Department of Environmental Quality every 10 years after the last approval. The jurisdictions of Essex, King and Queen, King William, Mathews, Middlesex, Tappahannock, Urbanna and West Point opted to prepare a regional plan with assistance from Middle Peninsula Planning District Commission staff and EEE Consulting, an environmental Quality for compliance review by the November 2, 2011 deadline for Regional Plan submission.

• Drafted an alternatives addendum to be uploaded into Virginia Hydro. This addendum states: *Middle Peninsula water sources should not be diverted, pro-rated, allocated, shared, distributed or given to adjacent urban areas as the demand for water increases with time, but rather should be left available to Middle Peninsula localities for future needs.* To date, the addendum has been uploaded for the following localities: Essex and King and Queen Counties and the Towns of West Point, Tappahannock and *Urbanna.* MPPDC staff is still waiting for responses from Mathews, Middlesex and King William Counties.

Middle Peninsula Chesapeake Bay Public Access Authority Special Project – Support of Executive Order 23, Goal 8 Coastal Management Coordination Public Access: Continue implementation of adopted annual work program, including identifying land, either owned by the Commonwealth or private holdings that can be secured for use by the general public as a public access site; researching and determining ownership of all identified sites; determining appropriate public use levels of identified access sites; developing appropriate mechanism for transferring title of Commonwealth or private holdings to the Authority; developing appropriate acquisition and site management plan. This Program allows the Authority to function by supporting the individual projects and operations of the Authority, as well as, by responding to daily requests for assistance from local government staff.

Project 32016 - VIMS Living Shoreline

MPPDC submitted a proposal to the National Fish and Wildlife Foundation for VIMS. The objective of this project is to leverage previous funding from NFWF to install oyster bag sills at two publicly-owned (MPCBPAA) properties on and monitor them for a year. In addition, existing oyster bag sill installations at four private locations will be monitored to determine overall project effectiveness. This work will provide recommendations for installations along fetch-limited shorelines of Chesapeake Bay.

Project 32017 – NAWCA PAA Acquisitions

The Wetlands Conservation on the Middle Peninsula of Virginia Phase I proposal is the first in a series of projects planned by the Middle Peninsula District Commission (MPPDC) in coordination with local, state and federal agencies, non-government organizations and landowners to protect key wetlands along the Chesapeake Bay. This project will employ a novel, creative and cost effective land conservation model in order to perpetually protect 77.05 acres of coastal habitat.

Project 32141 – Working Waterfront Zoning and Coastal Living Policy Development

MPPDC staff in partnership with Accomack-Northampton PDC and the Northern Neck PDC will work to develop a legislative brief for the 2018 General Assembly Session. Also staff will work with localities to develop working waterfront zoning and coastal living policy language. This work will then be shared with interested Board of Supervisors, Town Councils and the general public.

Received an update regarding the Working Waterfront project from Shannon Alexander, ANPDC. She explained that efforts to organize options for localities to consider the development of a Working Waterfront Development Area is taking longer than expected. Therefore, this project will be extended until December 31st. This will provide ample time to conduct outreach efforts to localities.

Project 32142 – ANPDC Ecotourism

This project is a collaboration between rural PDCs (ANPDC, NNPDC, and MPPDC) to develop and expand watertrails within each region. MPPDC staff will focus on developing watertrails on the York River, Pamunkey River, Mattaponi River and the Mobjack. MPPDC staff will also work with PDCs to create an interactive itinerary tool and to develop an overall Rural Coastal Virginia Water Trails theme/brand.

Project 30420/30428 - On-Site Technical Guidance Assistance and Revolving Loan Program

The On-Site Technical Guidance Program aids the Middle Peninsula localities and residents in the technical understanding and implementation of approaches to address On-Site Disposal Systems and improve water quality by assisting local homeowners with repairing failing septic systems through low-interest loans and/or grants. In addition MPPDC received funding under the Water Quality Improvement Fund (WQIF) to provide grants to low to moderate income Middle Peninsula and New Kent County homeowners to repair failing septic systems impacting water quality and health in the region. Grants can be paired with loans from the MPPDC Onsite Wastewater Revolving Loan Fund to provide matching funds as required. It is anticipated this funding will be used to provide assistance to 20-27 homeowners.

- Consulted with Tammy Faulkner, Gloucester Health Department and Crystal MacWelch, Millers Septic regarding application for a Gloucester repair. Homeowner is confused as to next steps to submit a complete application. Discussed options hook-up to sewer (MPPDC cannot provide financial assistance for this); design, permit and install alternative system; request GMP Waiver and install new conventional system. Homeowner has 10-12 people living in 4 bedroom house, and is not eligible for grant assistance due to income above the threshold (none of the other people living in the house meet the definition for federal dependents).
- Received phone call from Gloucester homeowner. Discussed MPPDC Septic Repair program and mailed application.
- Discussed Gloucester application with Brian Hancock, AOSE. Discussed 930 waiver option.
- Received phone call from Gloucester resident regarding failing septic system on property owned by her mother. Discussed application process.
- Received phone call from Gloucester homeowner. Mailed application.
- Received phone call from homeowner referred by Boyd Wiley, Town of Urbanna regarding septic permitting process. Discussed MPPDC program, permitting process, possible options.
- Received phone call from Gloucester homeowner regarding status of application. Homeowner has not provided a permit or estimate. Discussed next steps required before application can be approved.
- Emailed application to homeowner referred by Turlingtons Septic.
- Consulted with Tammy Faulkner, Gloucester Health Department regarding repair permit for Gloucester project.
- Executed ACH loan payments for septic repair loans. All MPPDC loan funding programs require that loan recipients authorize loan payments to be made automatically from loan recipients' bank accounts. Loan clients authorize the payments at loan closing (ACH Authorizations). These payments occur on the 15th of each month. This places the onus to not make a payment on the loan client contacting MPPDC staff prior to the loan processing date of the 12th of the month to request a payment to be held. This has significantly reduced defaults and delinquent repayments of MPPDC loans as well as collection efforts.
- Remaining uncommitted septic repair funding \$80,147 in loan funds, \$94,123 in grant funds.

ECONOMIC DEVELOPMENT Funding – EDA, local match from MPPDC General Fund, BDP Loan Program Income

Project 30115 - Blue/Green Infrastructure

Commission's effort to promote compatible economic development across the Middle Peninsula looking to leverage blue and green assets.

- Attended the Healthy Watersheds presentation in Essex County on August 14th. Essex County Board approved being one of two pilot localities for Phase III. This project has implications for all MPPDC localities as Phase III seeks to create a structure that will monetize blue green infrastructure.

Principal repaid will be held until the Commission determines the best use for these funds as allowed by the USDA (RBEG) original lending restrictions. Interest earned will be used to offset administration costs.

This program responds to daily requests for technical assistance which other commission programs are unable to provide.

- Participated in webinar for the National Fish and Wildlife Foundation Small Watershed Grant on July 23rd, and began to draft an application focused on implementing shoreline protections on contiguous parcels of land with repetitive loss claims.
- Participated in webinar for the National Fish and Wildlife Foundation Chesapeake Bay Innovative Nutrient and Sediment Reduction grant on July 25th.
- Drafted and submitted a grant proposal to the National Fish and Wildlife Foundation to focus on the conservation/resiliency/protection aspects of the three Guinea Marsh Islands (i.e. Hog Island and two adjacent islands) leading into Monday Creek.
- Drafted a letter to localities advising them of the availability of VA Waterway Maintenance Fund grant program.
- Drafted an estimate of hours needed to complete an application to the VA Waterway Maintenance Fund through the Virginia Port Authority for shallow water dredging projects.
- Created a map of all open space easements in Essex County for the Essex County Countryside Alliance.
- Consulted with Jackie Rickards regarding living shoreline program for background information for NFWF proposal.
- Registered several Commissioners to attend VAPDC Summer Conference in July. Three Commissioners attended.
- Coordinated the MP/NN Quarterly Emergency Management Meeting in Tappahannock with Essex County EM staff. Held a Satellite Phone training for the Middle Peninsula EM staff. Participants in the training were: Essex, King and Queen, Mathews, Gloucester and King William Counties.
- Participated in the Planning Meeting for the Rural Resiliency Forum, that is scheduled to take place October 23rd. The goal of the meeting was to start the process of creating a Rural Resiliency Framework, which could potentially help coordinate existing programs, identify gaps, and bring innovative ideas to the forefront. Many suggestions for structure and content for the October meeting were recommended by the participants. The Resilient Virginia organization is expected to have a draft agenda at the next planning meeting (TBD).
- Attended Mathews County's kickoff meeting for developing a Community Emergency Response Team (CERT). Many community members, representing interests from a large cross section of the County's citizens, attended and responded favorably to the idea of creating a Mathews County CERT Team. The next step will be a series of trainings by the Mathews County Emergency Management program. Estimated training start date is early this fall.

- Attended the VDEM Open Forum at the William and Mary School of Education. Dr. Jeff Stern, VDEM State Coordinator, spoke of the state of VDEM. VDEM is experiencing a budget shortfall due to continued decline in Federal Grants and a lack of baseline state funding. VDEM has cut \$5 million dollars from this year's budget, primarily in training and exercise programs.
- Assisted PDC Planning staff with grant proposal budgets NFWF, FEMA, RSAG applications.

Project 31002 – GA Lobby

This program provides professional services to represent Middle Peninsula interests at the General Assembly during the current session.

HOUSING

Funding –Housing Loan Program Income

Project 300132 – Energy Efficiency and Conservation Block Grant (EECBG) Revolving Loan Fund

The program emphasizes a community-based approach to help meet energy and climate protection goals. MPPDC was awarded a contract to provide weatherization renovations to 12 homeowners ineligible for LMI weatherization programs in each of the 6 counties. MPPDC subcontracted the promotion and construction portions of this project to Bay Aging but was tasked with administering the overall project. MPPDC is administering the revolving loan program per DMME.

- Executed ACH loan payments for MPBDP loans. All MPPDC loan funding programs require that loan recipients authorize loan payments to be made automatically from loan recipients' bank accounts. Loan clients authorize the payments at loan closing (ACH Authorizations). MPPDC staff process these payments on the 15th of each month. This places the onus to not make a payment on the loan client contacting MPPDC staff prior to the loan processing date of the 12th of the month to request a payment be held. This has significantly reduced defaults and delinquent repayments of MPPDC loans.
- *Funds available* = \$44,104

Project 30115 – VHDA Community Impact Grant

This project will consider new approaches to address vacant homes and clouds on deeds within the Middle Peninsula. Using recommendations derived from VCPC's extensive policy analysis, MPPDC will identify feasible strategies to address housing issues in the region. This work will also include a limited field inventory which will help MPPDC better evaluate how many vacant homes are in the Middle Peninsula. The short-term objective of Phase I is to identify tools available to address housing vacancies and determine how many vacant homes are in the Middle Peninsula. MPPDC will contract with VCPC and the Berkley Group to provide needed analysis and footwork.

- Created an online map using Dominion data that shows the relative location of address points that have had power turned off for over a year.
- Distributed a request to all Middle Peninsula localities to select a sample area for vacant housing survey using Dominion Energy data sets.
- Discussed updates to the Vacant Housing legal research study with staff from the Virginia Coastal Policy Law Center located at the College of William and Mary.

EMERGENCY SERVICES

Funding - VDEM/FEMA/Homeland Security

Project 31207 – MP/NN Mass Casualty Exercise

The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs), identified the need of integrating as a region, including the need for a regional exercise that would require multiple jurisdictions to carry out a coordinated response to an incident. This functional exercise will include the Middle Peninsula, will invite the Northern Neck, and will provide jurisdictions that recently purchased regional support trailers, the opportunity to deploy and use that gear in a simulated real-world event.

- Prepared and submitted quarterly financial report and reimbursement request.
- Consulted with Richard Hazel, VDEM regarding MPPDC ICAP.
- Met with Matthew Carpentier, Three Rivers Health District, to finalize the September 23rd exercise details.
- Set up a planning meeting with participating localities. The meeting will go over the goals, objectives and logistics of the exercise.
- Participated in the (VDEM) Region I Cyber Workshop at the New Kent Emergency Operations Center. The goals of the meeting were:
 - Share information on state level cyber security initiatives.
 - Develop partnerships between state and localities.
 - Identify resources and opportunities to bolster local and state cyber security through regional model.
 - Improve coordination and partnership between IT, Emergency Management, and Law Enforcement.

Project 31208 – MP/NN Regional Debris Management Plan

The Middle Peninsula/Northern Neck Debris Management Plan improves and supports the jurisdictions within the Middle Peninsula/Northern Neck's Operational Coordination, Information Sharing and Recovery Planning. The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs), identified the need to develop a Regional Debris Removal Plan that would engage the 10 county area in a joint planning process.

- Prepared and submitted quarterly financial report and reimbursement request.
- Continued to review Debris Management Plans from various Virginia localities and other states.
- Completed the 5-part webinar series offered by the National Hurricane Program as a comprehensive HURREVAC course for the emergency management community. This year's training was taught using the new web browser-based platform called HVX-HURREVAC.
 - Day 1 introduced the program's overall purpose and basic operation.
 - Day 2 covered the program's tools to support evacuation decisions.
 - Day 3 covered the program's tools to support understanding of potential wind timing and intensity.
 - Day 4 covered the program's other features to support hurricane response and decision making.
 - Day 5 demonstrated how to use HURREVAC to answer scenario-based questions.

Congressman Robert Wittman's Fisheries Advisory Committee and Environmental Advisory Committee: (MPPDC Staff 8 years +)

Virginia Sea Grant Program External Advisory Committee (EAC): The EAC provides stakeholder input on the strategic planning process, the research proposal review process, and on Commonwealth-wide trends and needs. The EAC is a diverse group of end-users including representatives from state agencies, the education community, coastal planning and management, the private sector, and NGOs. (MPPDC Staff 9 years+)

The Association for Commuter Transportation (ACT) (Telework Council Secretary): ACT is the premier association for professionals and organizations whose focus is the delivery of commuting options and solutions for an efficient transportation system. The Telework Council is concerned with promoting telework and providing telework information and technical assistance to employers (MPPDC Staff 10 years+)

Middle Peninsula Northern Neck Coordinated Human Services Mobility Committee: Provides direction for a unified comprehensive strategy for transportation service delivery in the Middle Peninsula and Northern Neck Planning Districts focused on unmet transportation needs of seniors, people with disabilities, and people with low incomes. (MPPDC Staff 12 years)

The Coastal Society: The Coastal Society is an organization of private sector, academic, and government professionals and students. The Society is dedicated to actively addressing emerging coastal issues by fostering dialogue, forging partnerships, and promoting communications and education. (MPPDC staff serves as a Director)

Hurricane Evacuation Coordination Workgroup: The Hurricane Evacuation Coordination Workgroup is comprised of state and local emergency representatives tasked with finding solutions to fill in the gaps in the Commonwealth's and Locality's plans to respond to a Major Hurricane Evacuation.

Shelter Location Identification Subcommittee of the Hurricane Evacuation Coordination Workgroup: Local and state experts tasked with identifying state and local shelter locations that can meet the needs of individuals with access and functional needs. Stakeholder Advisory Group for fees related to the consolidated Virginia Erosion and Stormwater Management Program: Item 8 of Chapters 68 and 758 of the 2016 Acts of Assembly directed Virginia Stormwater Management Program Authorities and Virginia Erosion and Sediment Control Program Authorities to submit information to DEQ by August 1, 2016 and directed DEQ to conduct its evaluation based on revenues and resource needs from July 1, 2014, to June 30, 2016.

Project 30502 Water Supply Planning

9 VAC 25-780 establishes a planning process and criteria that all local governments will use in the development of local or regional water plans. The plan will be reviewed by the Department of Environmental Quality and a determination will be made by the State Water Control Board on whether the plan complies with this regulation. Within five years of a compliance determination by the board, the plan will be reviewed to assess adequacy and any significant changes will require the submission of an amended plan and review by the board. All local programs will be reviewed, revised, and resubmitted to the Department of Environmental Quality every 10 years after the last approval. The jurisdictions of Essex, King and Queen, King William, Mathews, Middlesex, Tappahannock, Urbanna and West Point opted to prepare a regional plan with assistance from Middle Peninsula Planning District Commission staff and EEE Consulting, an environmental Quality for compliance review by the November 2, 2011 deadline for Regional Plan submission.

• Uploaded the alternatives addendum to Virginia Hydro for Middlesex County. This addendum states *Middle Peninsula water sources should not be diverted, pro-rated, allocated, shared, distributed or given to adjacent urban areas as the demand for water increases with time, but rather should be left available to Middle Peninsula localities or future needs. To date, the addendum has been uploaded for all participating localities.*

Project 32017 – NAWCA PAA Acquisitions

The Wetlands Conservation on the Middle Peninsula of Virginia Phase I proposal is the first in a series of projects planned by the Middle Peninsula District Commission (MPPDC) in coordination with local, state and federal agencies, non-government organizations and landowners to protect key wetlands along the Chesapeake Bay. This project will employ a novel, creative and cost effective land conservation model in order to perpetually protect 77.05 acres of coastal habitat.

The intent of this project initiative is for each Virginia Planning District Commission (PDC) covering Chesapeake Bay watershed localities to convene locality and regional officials, staff and stakeholders to provide input and recommendations for meeting Local Area Planning Goals (LAPGs) in accordance with the DEQ-provided "Outline for Local Area Planning Goal Initiative".

In addition MPPDC received funding under the Water Quality Improvement Fund (WQIF) to provide grants to low to moderate income Middle Peninsula and New Kent County homeowners to repair failing septic systems impacting water quality and health in the region. Grants can be paired with loans from the MPPDC Onsite Wastewater Revolving Loan Fund to provide matching funds as required. It is anticipated this funding will be used to provide assistance to 20-27 homeowners.

This program responds to daily requests for technical assistance which other commission programs are unable to provide.

Project 300132 – Energy Efficiency and Conservation Block Grant (EECBG) Revolving Loan Fund

The program emphasizes a community-based approach to help meet energy and climate protection goals. MPPDC was awarded a contract to provide weatherization renovations to 12 homeowners ineligible for LMI weatherization programs in each of the 6 counties. MPPDC subcontracted the promotion and construction portions of this project to Bay Aging but was tasked with administering the overall project. MPPDC is administering the revolving loan program per DMME.

This has significantly reduced defaults and delinquent repayments of MPPDC loans.
- *Funds available = \$44,142*

Project 30115 – VHDA Community Impact Grant

This project will consider new approaches to address vacant homes and clouds on deeds within the Middle Peninsula. Using recommendations derived from VCPC's extensive policy analysis, MPPDC will identify feasible strategies to address housing issues in the region. This work will also include a limited field inventory which will help MPPDC better evaluate how many vacant homes are in the Middle Peninsula. The short-term objective of Phase I is to identify tools available to address housing vacancies and determine how many vacant homes are in the Middle Peninsula. MPPDC will contract with VCPC and the Berkley Group to provide needed analysis and footwork.

- Continued research on vacant and dilapidated housing across the Middle Peninsula. Received responses from interested localities within the Middle Peninsula for inclusion in a survey to better understand the relationship between vacancy, Dominion Energy services and hosing stock improvements.
- Discussed possible legislative approaches that helps improve vacant housing across the Middle Peninsula with Delegate Keith Hodges.
- Discussed Dominion Energy's provided data base of accounts with no power for more than one year with Gloucester County staff and Dominion staff for clarification concerning the inclusion of renter data.

EMERGENCY SERVICES Funding – VDEM/FEMA/Homeland Security

Project 31207 – MP/NN Mass Casualty Exercise

The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs), identified the need of integrating as a region, including the need for a regional exercise that would require multiple jurisdictions to carry out a coordinated response to an incident. This functional exercise will include the Middle Peninsula, will invite the Northern Neck, and will provide jurisdictions that recently purchased regional support trailers, the opportunity to deploy and use that gear in a simulated real-world event.

 Held a Mass Casualty Exercise Planning Meeting. Attendees included representatives from Middlesex County, Mathews County, Gloucester County, MPPDC, Lancaster County, and Three Rivers Health District. Agenda included Exercise Design, Exercise Logistics, and Exercise Communications. The exercise is scheduled for September 22 at the Cooks Corner Complex in Saluda, VA.

- Continued to finalize the details for the Exercise.
- Provided Valerie Avery-Birkett, Coordinator for Three Rivers Medical Reserve Corps with a list of Emergency Managers for the Middle Peninsula and Northern Neck areas.

Project 31208 – MP/NN Regional Debris Management Plan

The Middle Peninsula/Northern Neck Debris Management Plan improves and supports the jurisdictions within the Middle Peninsula/Northern Neck's Operational Coordination, Information Sharing and Recovery Planning. The 2017 Gap Analysis of the Middle Peninsula/Northern Neck's Emergency Operations Plans (EOPs), identified the need to develop a Regional Debris Removal Plan that would engage the 10 county area in a joint planning process.

Virginia Sea Grant Program External Advisory Committee (EAC): The EAC provides stakeholder input on the strategic planning process, the research proposal review process, and on Commonwealth-wide trends and needs. The EAC is a diverse group of end-users including representatives from state agencies, the education community, coastal planning and management, the private sector, and NGOs. (MPPDC Staff 9 years+)

The Association for Commuter Transportation (ACT) (Telework Council Secretary): ACT is the premier association for professionals and organizations whose focus is the delivery of commuting options and solutions for an efficient transportation system. (MPPDC Staff 12 years)

The Coastal Society: The Coastal Society is an organization of private sector, academic, and government professionals and students. The Society is dedicated to actively addressing emerging coastal issues by fostering dialogue, forging partnerships, and promoting communications and education. (MPPDC staff serves as a Director)

Hurricane Evacuation Coordination Workgroup: The Hurricane Evacuation Coordination Workgroup is comprised of state and local emergency representatives tasked with finding solutions to fill in the gaps in the Commonwealth's and Locality's plans to respond to a Major Hurricane Evacuation.

Shelter Location Identification Subcommittee of the Hurricane Evacuation Coordination Workgroup: Local and state experts tasked with identifying state and local shelter locations that can meet the needs of individuals with access and functional needs. Eastern Virginia Groundwater Management Advisory Committee (EVGMAC) Workgroup #2B: EVGMAC is charged with assisting the State Water Commission and DEQ in developing, revising and implementing a management strategy for groundwater in Eastern Virginia Groundwater Management Area. Group #2B will identify trading options and programs used in other states; evaluate how trading programs might help with future growth and development, and individual and regional solutions; and evaluate feasibility, data needs, cost and possible participants.
